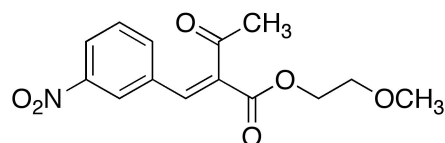

**Eye/Face Protection**
