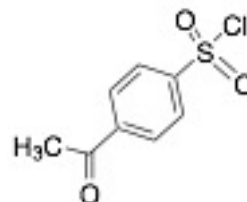

General Advice

Personal Protective Equipment

Eye/Face Protection

Skin Protection
