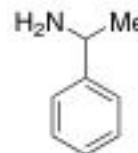

4. FIRST AID MEASURES

4.1 Description of First Aid Measures

General Advice

If medical attention is required, show this safety data sheet to the doctor.

If Inhaled

If inhaled, move casualty to fresh air. If not breathing, give artificial respiration and consult a physician.

6. ACCIDENTAL RELEASE MEASURES

6.1 Personal Precautions, Protective Equipment and Emergency Procedures

discharge, must be removed from area.

7. HANDLING AND STORAGE

7.1 Precautions for Safe Handling

Avoid contact with skin and eyes. Ventilation and proper handling are to be used to prevent the formation of vapours and mists. Remove all sources of ignition and take precautionary measures to prevent the buildup of electrostatic discharge (ground and bond containers as appropriate). No smoking, eating or drinking around this material. Wash hands after use.

7.2 Conditions for Safe Storage, Including any Incompatibilities

Ensure container is kept securely closed before and after use. Keep in a well ventilated area and do not store with strong oxidizers or other incompatible materials (see Section 10).

Appropriate Engineering Controls

A laboratory fumehood or other appropriate form of local exhaust ventilation should be used to avoid exposure.

Personal Protective Equipment

Eye/Face Protection

Skin Protection

Gloves should be used when handling this material. Gloves are to be inspected prior to use. Contaminated gloves are to be removed using proper glove removal technique so that the outer surface of the glove does not contact bare skin. Gloves used for incidental exposures (splash protection) should be designated as "chemical resistant" by EU standard EN 374 with the resistance codes corresponding to the anticipated use of the material. Unrated gloves are not recommended.
