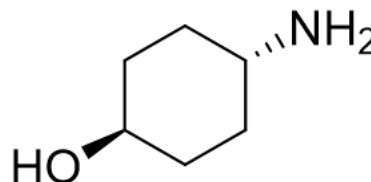

General Advice
