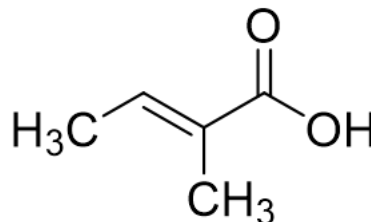

General Advice

Eye/Face Protection
