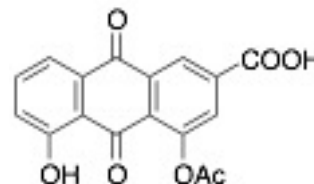

Appropriate Engineering Controls

Personal Protective Equipment
