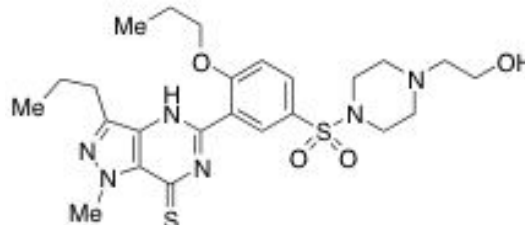

Appropriate Engineering Controls
