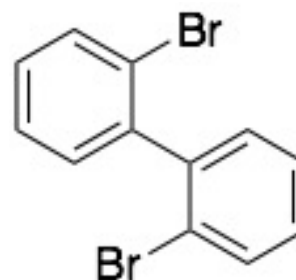

Eye/Face Protection
