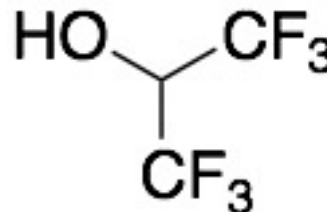

General Advice
