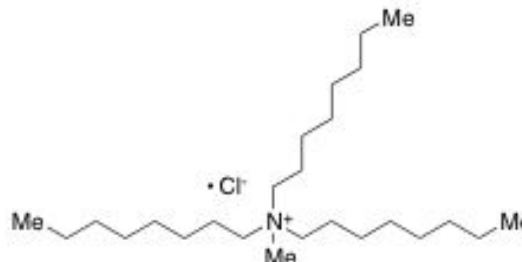

General Advice

Appropriate Engineering Controls

Eye/Face Protection
