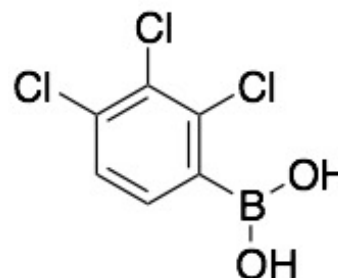

### Personal Protective Equipment
