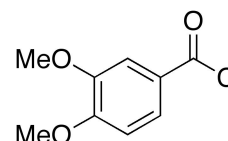

4.1 Description of First Aid Measures

General Advice

Appropriate Engineering Controls

Personal Protective Equipment

Eye/Face Protection

Skin Protection
