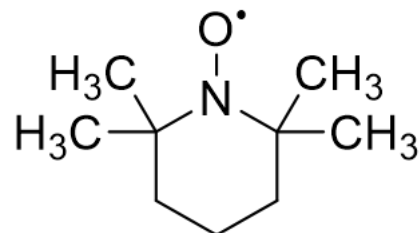

General Advice
