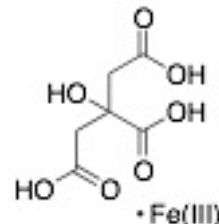

8.2 Exposure Controls

Appropriate Engineering Controls

A laboratory fumehood or other appropriate form of local exhaust ventilation should be used to avoid exposure.

Personal Protective Equipment

All recommendations below are advisory in nature and a risk assessment should be performed by the employer/end user prior to use of this product. The type of protective equipment must be selected based on the amount and concentration of the dangerous material being used in the workplace.

Eye/Face Protection

Skin Protection

Gloves should be used when handling this material. Gloves are to be inspected prior to use. Contaminated gloves are to be removed using proper glove removal technique so that the outer surface of the glove does not contact bare skin. Gloves used for incidental exposures (splash protection) should be designated as “chemical resistant” by EU standard EN 374 with the resistance codes corresponding to the anticipated use of the material. Unrated gloves are not recommended.
